Derived from animals which have been found by ante and post mortem veterinary inspection to be free from diseases designated by laws of Japan and suitable in every way for human consumption and that no injurious ingredient has been used in its production.</p> <p>1.2. Slaughtered and produced in a sanitary manner pursuant to the laws of the exporting country, which are at least equivalent to relevant Japanese laws</p> <p>1.3. Australia is free from Hog cholera, in Australia vaccination against Hog cholera, and the importation of pigs vaccinated against Hog Cholera, is prohibited.</p> <p>2. On the basis of the relevant health certificates from competent authorities of the third free country (see above) which have been approved by the Ministry of Agriculture, Forestry and Fisheries of Japan, I hereby certify that the pork originating from this country and described in this certificate was produced to comply with statement 1.1, 1.2 and</p> <p>2.1. Derived from a country recognised as free from foot and mouth disease, African swine fever, classical swine fever, swine vesicular disease and Trichinella spiralis for six month immediately prior to slaughter and export of animals and no contamination took place prior to export.</p> <p>2.2. These countries are free from Hog cholera. Vaccination against Hog cholera and the importation of pigs vaccinated against Hog cholera, is prohibited in these countries.</p> <p>2.3. Securely imported into Australia and accompanied by a health certificate (as above) and issued by the competent authority of the exporting country.</p> <p>3. All product was further processed /packaged/stored/transported in a sanitary manner and passed inspection in accordance with the Australian Export Control Act 1982.</p>
