

 - 5. the meat is free from any evidence of animal infectious diseases as a result of import inspection conducted by animal health authorities of the Netherlands and is directly carried into the designated facilities in the Netherlands after the said inspection.
- 5. The slaughtered cattle is not suspect or confirmed BSE case or cohort of BSE cases, as defined in the Terrestrial Animal Health Code adopted by the World Organization for Animal Health (OIE).
- 6. The slaughtered cattle is found to be sound and healthy as a result of ante- and post mortem inspections conducted by the government veterinarians of the Netherlands in the designated facilities at the time of slaughter.
- 7. The exported beef and beef offal to Japan is handled in such a way as to prevent contamination with any causative agents of animal infectious diseases until shipment to Japan.
- The meat is containerised in an enclosed ocean/air vessel container. This container is sealed under supervision of by the animal health authorities of the Netherlands. The seal is placed on the container in a way to ensure that opening of the container is impossible without breaking the seal.

- 1. NAI and Newcastle Disease are notifiable diseases. These diseases must be brought to the attention of the competent authority of Kingdom of the Netherlands immediately after an outbreak is detected or suspected in accordance with national regulation.
- 2. The surveillance program for NAI based on the OIE Code is implemented by the competent authority of Kingdom of the Netherlands.
- 3. Vaccination against NAI is prohibited in Kingdom of the Netherlands, except for the vaccination of rare birds in zoos under official supervision of the competent authority of Kingdom of the Netherlands.

B. Requirements regarding origin of poultry

- 1. Kingdom of the Netherlands has been free from NAI for at least 90 days before the day of shipment of poultry meat etc. to be exported to Japan.
- 2. However, in case Kingdom of the Netherlands has an outbreak of LPAI and the Japanese animal health authority confirm the facts in a), b) and c) below based on the information provided by the animal health authority of Kingdom of the Netherlands, the poultry meat etc. which satisfy conditions of d) and e) below are eligible to be exported to Japan from the free regions.
 - a) appropriate containment measures such as movement restriction of the poultry etc., stamping out and disinfection are fully implemented at the premises where outbreak of LPAI occurred;
 - b) epidemiologically-linked premises of the premise where outbreak of the LPAI was confirmed have been identified and appropriate control measures such as the movement restriction are implemented on those premises. If an outbreak of LPAI would be found in such premises, the AHM(s) in which the premises are located would be regarded as an infected region(s);
 - c) the control zone has been established, centering around the premise where the outbreak of LPAI was confirmed, and appropriate containment measures such as movement restrictions and surveillance for LPAI are implemented in it;
 - the live poultry used for the production of the exported poultry meat etc. originates from free regions and has been transported into the poultry slaughtering facilities only via free regions; or

If they pass through the infected regions before being carried into slaughterhouses, appropriate vehicles in terms of animal health which do not allow contamination of LPAI virus during the transport must be used. In addition, the competent authority of Kingdom of the Netherlands must ensure that the poultry were directly sent from the origin of them to the slaughterhouses in the vehicle which was not opened on the way.

- e) before the shipment to Japan, the exported poultry meat etc. is stored in clean and secure wrapping or container and transported in a safe and sanitary manner from the animal health point of view, in order to avoid the contamination with any pathogens of animal infectious diseases.







IV. HEALTH ATTESTATION

I the undersigned Stated Veterinary Surgeon Licensed by the Dutch Government do hereby certify that:

- 1. The meat described in this certificate was derived from pigs which have been examined and found by ante mortem and post mortem veterinary inspection to be free from diseases designated by laws of the importing country and suitable in every way for human consumption and that no injurious ingredient has been used in its production. The slaughter and processing of the meat described in this certificate has been done in a sanitary manner pursuant to the meat and hygienic laws in the Netherlands, or one of the third free countries, which are deemed to be equivalent to the Japanese Food Sanitation Law and the Japanese Abattoir Law.
- 2. The slaughtered pigs is found to be sound and healthy as a result of ante- and post mortem inspections conducted by the government veterinarians of the Netherlands, or one of the third free countries in the designated facilities at the time of slaughter.
- 3. The Netherlands is free from foot and mouth disease (FMD), Rinderpest and African Swine Fever (ASF).
- 4. Vaccinations against FMD, Rinderpest and ASF as well as importation of cloven-hoofed animals which have been vaccinated against any of these diseases are completely prohibited by laws of the Netherlands.
- 5. The pigs (including the boar), which have been slaughtered for the production of the exported pig meat, etc. to Japan shall have been born and raised only in the Netherlands, or shall have met all of the requirements in the following items:
 - 1. The said pigs have been born and raised only in the third free countries.
 - 2. The said pigs have been free from any evidence of animal infectious diseases as a result of export inspection conducted by the animal health authorities of the third free countries.
 - 3. The said pigs have been directly imported to The Netherlands from the third free countries, and shall have been accompanied with the inspection certificate issued by the government authorities of the third free countries, and shall not have been transported through other countries than the third free countries concerned.
 - 4. The said pigs have been free from any evidence of animal infectious diseases as a result of import inspection conducted by the animal health authorities of the Netherlands.
 - 5. The slaughtered pigs has been free from any evidence of infectious diseases as a result of anteand post mortem inspections conducted by the government veterinarians of the Netherlands at the designated facilities.
- 6. The pig meat, etc. which have been used for the production of the exported pig meat, etc. to Japan shall have originated from the pigs (including the boar) which have been born and raised only in the Netherlands, or shall have met all of the requirements in the following items:
 - 1. The pig meat, etc. has been derived from pigs (including the boar) which have been born and raised in the third free countries.
 - 2. The pig meat, etc. has been derived from pigs (including the boar) which have been free from any evidence of infectious diseases as a result of ante- and post mortem inspection conducted by the official veterinarians of the third free countries at the designated facilities.
 - 3. The pig meat, etc. has been directly imported to The Netherlands from the third free countries, without transiting through other countries than the said third free countries, and shall have been accompanied by the inspection certificate issued by the government authorities of the third free countries.
 - 4. The pig meat, etc. has been free from any evidence of animal infectious diseases as a result of import inspection conducted by the animal health authorities of The Netherlands, and shall have been directly carried into the designated facilities in the Netherlands after the said inspection.
- 7. The exported pig meat, etc. to Japan shall be handled in such ways as to keep it from being contaminated with any causative agents of animal infectious diseases until the shipment. Clear and sanitary wrappings and / or containers such as cardboard boxes shall be used to pack the exported pig meat, etc. to Japan.

- 8. In case of the casings for the production of exported pig meat, etc. which have been derived from cattle, sheep and goat should be originated only from the countries other than the EU members countries and from the countries that have no indigenous case of BSE, and have been handled only at designated facilities which are handling only the casings from the countries other than EU member countries, and from the countries that have no indigenous case of BSE.
- 9. Requirements for Classical swine fever (CSF):
 - 1. The Netherlands is free from CSF, (both in the domestic pigs and the wild pig outbreak case).
 - 2. Vaccination against CSF is prohibited in The Netherlands
 - 3. Importation of pigs vaccinated against CSF into the Netherlands is prohibited.
 - 4. In case the pigs or the pig meat etc. from the third free country are used for the production of the exported pig meat etc. The animal health authorities of The Netherlands shall be responsible for certifying that:
 - A third free country or zone is free from CSF;
 - Vaccination against CSF is prohibited in a third country or zone;
 - Importation of pigs vaccinated against CSF is prohibited in a third free country or zone.
 - 5. The feeding of swill is prohibited in The Netherlands, unless the swill has been treated to inactivate any CSF virus.
